

institutions as the said Jamssetjee Nusserwanjee Tata through agents in England and the said Freemy K. R. Kama shall from time to time select for two years at the least and for three years at the most with due diligence by way of attending lectures and readings and - acquiring clinical practice and experience, the study and cure of Diseases of Women and Children or any particular diseases whether of women and children or otherwise for which study she the said Freemy K. R. Kama may exhibit special aptitude or predilection and shall after she shall have mastered the subject or subjects selected by her as aforesaid by due diligence qualify for and obtain the Diplomas and degrees abovementioned and shall after obtaining such diplomas and degrees return to India and begin to practise as a physician generally and in the particular branch of medicine or Diseases she shall have specially studied as aforesaid.

2. That in consideration of the agreement on the part of the said Freemy K. R. Kama in the last preceding paragraph hereof contained and of the agreement on her part also hereinafter contained the said Jamssetjee Nusserwanjee Tata shall provide the following expenses of the said Freemy K. R. Kama that is to say the expense of and attending her outfit, her passage money as a first-class passenger to England including her return passage the fees payable for her attendances at such lectures as she may have to attend and such clinical practice as she will have to follow, the expense of supplying herself with such medical works and such surgical and other instruments as may be necessary for the proper prosecution of her studies the expenses attending her travel in and from such continental city or cities as she may have to sojourn at and in addition thereto a sum of £. Ten per month for her board and lodging while in England or on the Continent of Europe so nevertheless that the aggregate of such expenses during the period of study shall not exceed the sum of Rupees ten thousand ~~as~~ aforesaid all such payments to be made from time to time as may be required, and to be vouched for by written acknowledgments to be passed from time to time by the said Freemy K. R. Kama.

3. That all such sums as may be expended for or paid to the said Freemy K. R. Kama as aforesaid shall be considered as taken as moneys lent and advanced to her and shall carry simple interest at Four per cent per annum from the respective times the same shall be respectively so advanced and shall with such interest be repaid by the said Freemy K. R. Kama by annual instalments not less on an average than such amount as shall be equivalent to one fifth part of the annual income which the said Freemy K. R. Kama after she shall have returned to India whether qualified as aforesaid or not and whether at the expiration of the time hereinafore limited or before or after that time may earn or but for her own default might earn by her practice in India, the first of such instalments to be due as soon as she begins to earn Rupees 150-00-

per mensom.

4. Provided that nothing herein contained shall prevent the said Freany K. R. Kama from paying off the whole or the whole remainder at any time of the said debt at once in consideration of interest being calculated at the rate of Three instead of Four percent per annum.

5. Provided also that if the said Freany K. R. Kama shall wilfully neglect or refuse to carry out her part of this agreement whether in regard to her studies and qualifications or regard to her return to India and her practising there she shall cease to receive further help from the said fund and shall be liable to repay forthwith the whole of the said debt and interest, or such part thereof as may be then due and owing in respect of such advances as aforesaid.

6. That while in England or on the Continent of Europe the said Freany K. R. Kama shall in the pursuit of her studies and her general conduct be under the superintendence and guidance and direction of the said Jansetjee Nusserwanjee Tata or such person or persons as may be appointed in this behalf by him as regards the subjects of her study the place or places where it shall be prosecuted and all other matters appertaining thereto.

7. That if the said Jansetjee Nusserwanjee Tata shall at any time hand over the residue for the time being of the said fund to the Committee of Management for the time being of the said scheme for Higher Education among Parsees and such Committee shall accept the said trust though not falling within the scope of the said scheme, then and in such case the rights and obligations of and under these presents shall ipso facto be and stand transferred to the said Committee in the same manner to all intents and purposes as if the said Committee had been parties to these presents from the date hereof.

8. Provided Always and it is hereby agreed and declared that the said Committee if and in so far as they shall assume the rights and obligations of these presents shall not be answerable or accountable for any bankers or broker or other persons with or into whose hands the funds in their charge or under their operation or any securities in which the same or any part thereof may be invested may in the ordinary course of business be deposited or come due for the non application or misapplication of any moneys which may be paid or expended by them or the loss of any moneys which may be forwarded by them to England or any place on the continent in the execution of the trusts and powers of these presents nor for any other loss unless the same shall occur through their own wilful default respectively nor shall any thing contained in these presents create or be deemed to create a personal contract or obligation on the part of them the said Committee with or towards the said Freany K. R. Kama except in so far only as the funds which may so be placed in their hands as aforesaid.
